### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is hereby executed on the **17<sup>th</sup> May, 2023** between **ASHOKNAGAR KALYANGARH MUNICIPALITY**, Ashoknagar, North 24-Parganas, West Bengal, 743222 hereinafter referred to as the **FIRST PARTY** which expression shall unless contrary to and or repugnant to the context mean and include its successors representative and permitted assigns through **Prabodh Sarkar, Chairman** of Ashoknagar Kalyangarh Municipality to enter into and sign this agreement for and on behalf of the **First Party**.

AND

**SREE CHAITANYA MAHAVIDYALAYA**, Habra, North 24-Parganas, West Bengal, 743268 hereinafter referred to as the **Second Party** which expression shall unless contrary to and or repugnant to the context mean and include its successors representative and permitted assigns through **Dr. Subrata Chatterjee** to enter into and sign this agreement for and on behalf of the **Second Party**.

#### Background of Ashokenagar-Kalyangarh Municipality

After the partition of Bengal, a section of people, through much in number, settled in and around erstwhile Habra P.S. areas of West Bengal. In 1955, after a popular agitation, Kalyangarh, the Government sponsored refugee settlement was declared urban status; however not municipal area, yet the then Government declared its responsibilities to urbanize the roads, drainage, sanitation, etc. With after dissatisfaction of the people, no work for urbanization was really undertaken in the decade of sixties. Subsequently in the year 1968, Ashokenagar-Kalyangarh Municipality was created. This municipality is situated within Ashokenagar police station under Barasat Sub-division of the district of North 24-Parganas, West Bengal.

#### Background of Sree Chaitanya Mahavidyalaya

**Sree Chaitanya Mahavidyalaya**, founded & established in 1965, was a dedicated College of Commerce in its former avatar Sree Chaitanya College of Commerce. The college is duly accredited by NAAC (Second Cycle). The college started offering numerous courses in Arts (Humanities) and Science apart from Commerce under the aegis of West Bengal State University. Previously the college taught under the University of Calcutta.

**Now, being that, this agreement witnesses the following terms & conditions to be performed by both the parties to the Agreement**

1. The both parties have agreed to accomplish the MOU in the terms of Rules 15 of the **SOLID WASTE MANAGEMENT RULES, 2016** framed under the **ENVIRONMENTAL (PROTECTION) ACT, 1986** and observance of any or all **ENVIRONMENTAL (PROTECTION) ACT, 1986** and observance of any or all


1. The both parties have agreed to accomplish the MOU in the terms of Rules 15 of the **SOLID WASTE MANAGEMENT RULES, 2016** framed under the **ENVIRONMENTAL (PROTECTION) ACT, 1986** and observance of any or all necessary circulars, guidelines and orders issued by the State Government from time to time in this respect (As per Memo No.758/AKM/2023 dt. 17/05/2023, issued with reference to the letter no. SCM/59/AKM/13(a)/22 dt. 25/08/2022).
2. It is understood that this agreement will come into effect after being signed by the two parties and will be established for a period of **five years**.
3. The **renewal** of the agreement is chargeable at the end of the tenure/period and the documentation formalities shall be done by the both parties within 30-45 days prior to the date of termination of this agreement.
4. The First Party has agreed to provide the logistic support including pick up, transport, **carry and recycle / dispose of** the solid waste (generated by the 2<sup>nd</sup> Party) from the **second party once in a week**.
5. The both parties have agreed to conduct the various programmes (Such as seminars, workshops, observance of important days, awareness programmes, rallies etc.) jointly on solid waste management, environmental protection and other related issues in a regular basis.
6. Either party can **terminate** this agreement by giving **45 days** written notice in advance to the other party. However, the other party is **not entitled** to claim any **compensation** for such premature termination, if it is done on account of reasonable and sufficient grounds.
7. **If any dispute arises in respect of the MOU, in that case, both the parties will discuss and settle the matter amicably.**
8. This agreement is a non-exclusive agreement and two parties remain free to enter into similar agreements with other parties.
