
NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH and it is agreed by and between both the Colleges hereto as follows:


1. SCM & PNDC have the necessary permission of the concerned Governing Bodies regarding the MoU.
2. That for the purpose mentioned *ut supra* both the colleges have agreed to exchange in the fields like Academic Exchange (including the joint classes held for the students of both the colleges, by the faculties of different departments) in a week / fortnight, the *modus operandi* of which will be settled jointly by the concerned departments of both the colleges.
1. Cultural exchange like commemoration of birth anniversaries of renowned personalities, observance of different International / National Days, celebration of local festivals, inter-college cultural competitions etc. may be organized jointly.
2. NSS activities: The colleges can share a few programmes of NSS activities as per the convenience and feasibility from both the colleges' end.
3. Research and Publication: Collaborative endeavours can be undertaken to publish research articles either in the proceedings of National and International seminars / webinars etc., and / or in the form of edited volumes. A well-concerted contribution of the academic journals of both the colleges, publishing of Students' Magazines / webzines, departmental e-journals etc.
4. Library facilities: Resources of both the colleges can be shared, *modus operandi* of which will be settled jointly by the Library departments of the colleges.
5. It is agreed by both the colleges that expenses to be incurred in connection with different programmes will be borne by the respective college of the participants/candidates.
6. Both the colleges have agreed that if additional assistance is required in that event Principal of both colleges will settle mutually after discussions.
7. That in respect of the abovementioned programmes and/or activities only Principals of both the colleges will take all responsibilities regarding selection of candidate(s)/participant(s) and other matters of the said purpose.
8. If any disputes arise in respect of this MOU in that case Principal of both the colleges will discuss and settle the matter amicably.
9. Both the colleges have entered into this Memorandum of Understanding for period of five years in first phase.
