VALIDITY:

The MoU shall be valid, initially for a period of 3 years, extendable for another two years by mutual consent.

SETTELMENT OF DISPUTES:

The parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Agreement or the interpretation thereof. If any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning operation, effect interpretation of the Agreement or breach thereof which Parties are unable to settle mutually within 30days from the commencement of settlement proceedings and if not settled then the same shall be referred to the court of West Bengal Jurisdiction.


TERMINATION:


This MoU may be terminated by giving a notice of three months or the conclusion of on-going programs, whichever is later, from either side.




