## About the Seminar

Sustainable development requires an integrated approach in planning which needs to integrate the environmental concerns in the economic development planning process. In India, the sustainability issue encompasses a variety of development schemes in social, cleantech (clean energy, clean water and sustainable agriculture) and human resources segments. In fact, India is expected to begin the greening of its national income accounting, taking into consideration the depletion of natural resources as a component in its measurement of gross domestic product (GDP). India's sustained efforts towards reducing greenhouse gases (GHG) will ensure that the country's per capita emission of GHG will continue to be low until 2030-31, and it is estimated that the per capita emission in 2031 will be lower than per capita global emission of GHG in 2005, according to a new study. Even in 2031, India's per capita GHG emissions would stay under four tonnes of CO<sub>2</sub>, which is lower than the global per capita emission of 4.22 tonnes of CO<sub>2</sub> in 2005.

The focus of the seminar is to cover all possible issues and challenges regarding sustainability in the context of Indian Economy.
